# I. Meeting Called to Order:

With a quorum present, Vice Chair Caroline St. Clair called the meeting of the Lake Holden Advisory Board (Advisory Board) to order at 5:31 p.m.

#### II. Approval of the June 21, 2017 Meeting Minutes:

Upon a Motion by Mike Powell, seconded by Dana Kruetzfeldt, and carried with all present members voting AYE by voice vote; the meeting minutes for June 21, 2017 were approved as submitted.

### **III.** Public Comment:

Vice Chair St. Clair opened the floor for public comment. Hearing no request, the public comment period was closed.

## IV. Environmental Protection Division (EPD) Report:

## **Alum Treatment Facility Operation & Maintenance Report**

On behalf of the City of Orlando Streets & Stormwater Division, Melissa Lavigne distributed the alum facility report covering May 2015 through June 2017. Discussion ensued.

#### **Aquatic Plant Management**

Melissa Lavigne reported EPD performed a BioBase survey in July 2017 to assess pondweed in areas restricting public navigation. Plant density maps were distributed. EPD will consult with the Florida Fish & Wildlife Conservation Commission (FWC) on amendments to Lake Holden's aquatic plant removal permit.

Upon a Motion by Mike Powell, seconded by Dana Kruetzfeldt, and carried with all present members voting AYE by voice vote; the Advisory Board requested EPD and FWC conduct a joint survey and subsequently treat pondweed in all areas approved by FWC.

#### **Welcome Commissioner Pete Clarke**

At the invitation of Chairman Lionel Robbins, Orange County District 3 Commissioner Pete Clarke and Senior Aide Mercedes Fonseca were in attendance. The Advisory Board welcomed them. The two newest members, Dana Kruetzfeldt and Caroline St. Clair, were introduced.

#### **Sunken Vessel**

The sunken vessel reported by Dana Kruetzfeldt and located offshore from 3789 Laguna Street was reported. Melissa Lavigne inquired if Florida registration numbers were visible on the boat. No one had seen the numbers.

# **Real Time Monitoring**

Melissa Lavigne and the Advisory Board discussed the possibility of a real-time water quality monitoring station on Lake Holden. The Advisory Board requested additional details about parameters, equipment, costs for installation and annual maintenance, etc.

## FDOT Pond Expansion

As requested by the Advisory Board, Melissa Lavigne emailed the Florida Department of Transportation (FDOT) on June 22, 2017 with Chairman Robbins' pond expansion concept. Awaiting response.

#### **Chairman Lionel Robbins**

- Tasked the Advisory Board members with prioritizing the recommended stormwater treatment options resulting from the Evaluation of Runoff Loadings and Impacts from Lake Holden Drainage Sub-Basins, October 2016 Environmental Research and Design, Inc.
- Inquired about any updates or changes to the Westmoreland Pond project.
  Melissa Lavigne provided a summary of the proposed project and stated there
  were no changes to the determination of maintenance responsibilities, i.e., the
  Lake Holden MSTU would be responsible for all future maintenance activities
  and associated costs if the pond retrofit moved forward. Commissioner Clarke
  requested a meeting with Public Works Stormwater and EPD.
- Discussed at length, details of the 43<sup>rd</sup> Street Pond and surrounding stormwater infrastructure (outfall pipe, open swale, inlets).

• Requested updated 5 year budget report.
