# Disability Advisory Board Meeting

# May 8, 2017

The meeting of the Orange County Disability Advisory Board was called to order at 2:03 p.m. on May 8, 2017, at the 2010 E. Michigan St., Facilities Training Center Meeting Room, Orlando, FL 32806. #### **Presentation**
