#### I. Meeting Called to Order:

## **II.** Approval of the March 21, 2018 Meeting Minutes:

### **IV.** Environmental Protection Division (EPD) Report:

#### **Aquatic Plant Management**

Melissa Lavigne relayed to the Advisory Board that the hydrilla treatment plans were prepared, and the herbicide application will occur before the end of the month. Treatment maps will be distributed at the next meeting.

# 43<sup>rd</sup> Street Stormwater Pond Retrofit Analysis and Design

Melissa Lavigne reported that Public Works and EPD concluded review and comments on the project proposal. Public Works is proceeding with preparing the task authorization request for the consultant, Geosyntec, Inc., to begin working on the scope of services.

Melissa Lavigne also stated that the stormwater outfall pipe leading from the 43<sup>rd</sup> Street Pond to Lake Holden was cleared by the County's maintenance unit on March 22, 2018.

#### **City of Orlando Alum Treatment System Report**

Melissa Lavigne distributed an operation and maintenance report for the Lake Holden Alum Treatment System (ATS). The ATS is operated and maintained by the City of Orlando, and the report covers a time period from June 13, 2017 to April 6, 2018.

Rick Richbourg expressed his desire to increase communication and coordination with the City of Orlando and mentioned a new City of Orlando homeowners' association representative.

#### **Officer Elections**

Melissa Lavigne encouraged the Advisory Board to begin thinking about nominations for Chair and Vice-Chair. Officer elections will be held during the upcoming meeting in May 2018. Elections were last held March 15, 2017.
