**IV. Environmental Protection Division (EPD) Report:**

**Orange County Sheriff's Office Lake Patrol Services**

Marson Nance distributed copies of the Orange County Sheriff's Office (OCSO) Lake Patrol Reports for April 2018.

- Marine Patrol Hours have increased to 32 hours per month for the summer.
- Patrolled lake on 14 shifts, 11 Days
- No vessel accidents
- 13 warnings issued, 1 Citations
- 14 boat inspections conducted
- Resident issued a written warning for a derelict vessel and is taking measures to remove it from the water.

**V. Spring/Summer Fertilizer Circular**

Marson Nance discussed the distribution of a circular that will be mailed to residents of the Lake Jessamine watershed. The circular will highlight the updates to Orange County's Fertilizer Management Ordinance.
