I.	<b><u>For Record (FR)</u></b>		There being a quorum, Vice-Chair, opened the hearing at 18:50 hours.
II.	<b><u>FR</u></b>		Vice-Chair conducted introduction of board members, explained role of the Animal Services Classification Committee.
III.	<b><u>Old Business</u></b>		Vice-Chair asked the Board if there were any questions regarding the minutes from July 12, 2018. No questions. Vice-Chair requested a motion to approve the minutes. Vice-Chair approved motion, second by Deputy Martin. Approved unanimously.
IV.	<b><u>New Business</u></b>		Co-Chair opened new business, case 18-19584 on appeal for the dog, Rico, owned by Annette Jordan. Sears stated she only received one packet for case 18-19580. Sears will not vote on case 18-19584. Vice-Chair allowed Attorney Thomas Nicholl on behalf of Annette Jordan to make a statement, followed by Annette Jordan-owner. Duff questioned Jordan, Jordan responded. Damone Franklin-co-owner/witness made a statement. Duff questioned Franklin, Franklin responded. Vice-Chair asked Board if they have any questions Burns asked for clarification on the

incident, Caraballo responded. Nicholl made statement. Vice-Chair clarified the current incident. Duff questioned Jordan, Jordan responded. Vice-Chair asked the Board if they had any more questions. No questions. Vice-Chair requested a motion to uphold or dismiss classification as Dangerous. Duff motioned to dismiss classification, second by Clark. Vote on the motion is held and passes (5 to 0 with 1 abstain). Rico is not classified as Dangerous. Deputy Martin made a statement. Vice-Chair addressed Jordan. Jordan responded.

Vice-Chair opened case 18-19580 on appeal for the dog Zeus aka Charlie, owned by Erin Swilley. Vice-Chair asked the Board Members if they had a chance to review the case. All said "yes". Vice-Chair allowed Kris Orndorff-victim to make a statement. Vice-Chair explained process of Dangerous Dog to Orndorff. Orndorff responded. Dr. Maria Martinez-witness made a statement. Vice-Chair asked the Board if they had any questions. Duff addressed Orndorff and Martinez. Cavagnaro questioned Caraballo, Caraballo responded. Cavagnaro had several questions for Orndorff, Orndorff and Martinez responded. Duff questioned Martinez, Martinez responded. Sears questioned Orndorff and Martinez, Orndorff and Martinez responded. Deputy Martin question Caraballo, Caraballo responded. Duff questioned Orndorff, Orndorff responded. Deputy Martin made a statement. Vice-Chair requested a motion. Burns motioned to uphold classification as Dangerous with euthanasia, second by Clark. Vote on the motion is held and passes (6 to 0). Zeus aka Charlie remains classified as Dangerous with intent to euthanize. Vice-Chair requested a recess.

V. Non-Agenda Items


