- I. Call to Order Mr. Arias, Chairman called the meeting to order at 12:03 pm.
 - o Pledge of Allegiance -. All.
 - o Invocation Mr. Roderick Davenport, Co-Chairman (District 6)
- II. Public Comment None. No further action was taken by the board.
- III. Introduction of New Members Mr. Matt Suedmeyer, Parks Manager, greeted the board and requested that everyone introduce themselves introductions were made around the room. Following introductions, Mr. Jeff Loeffert and Mrs. Kimberly Buchheit expressed their concerns regarding the attendance table in the Meeting Minutes (Minutes). IV. Approval of Meeting Minutes: Chairman Arias called for a motion to approve the meeting minutes September 13, 2018. Mr. Dewey Harvey made a motion that the September 13, 2018 Minutes be approved as presented. Mr. Bobby Beagles seconded the

- VI. Manager's Update (Projects, Issues & Section Updates) Matt Suedmeyer, Division Manager turned over the Selection of a new Co-Chairman to Mr. Arias. Mr. Suedmeyer also stated that because the board did not meet the required number of members at the August meeting, The Youth Sports Enhancement Grant submittal was omitted. Following the overview, Mr. Nelson presented the Azalea Park Little League grant application and funding request. Following an in-depth discussion Chairman Arias called for a motion. Mr. Roderick Davenport made a motion that the board accept and approve the full amount requested according to the application guidelines. Mr. Dewey Harvey seconded the motion. The board voted unanimously to approve the funding none opposed.
