- I. Call to Order Mr. Arias, Chairman called the meeting to order at 12:01 pm.

- II. Public Comment Chairman Arias asked if there was anyone for public comment Parks staff responded that there was none. Later, the visitors from Global Coach requested permission to speak. Chairman Arias asked if the board objected to allowing the visitors space to speak. Permission was granted. Ms. Calhoun and Mr. Vincent gave a brief synopsis of their business and reason for attending the meeting. Following a brief discussion i.e. questions, comments and general inquiry, it was suggested that Global Coach set meetings with the individual Orange County District Commissioners and also to coordinate with Parks staff regarding a pitch for their business. No further action was taken by the board.

- V. Manager's Update (Projects, Issues & Section Updates) Matt Suedmeyer, Division Manager. Mr. Suedmeyer then turned over the meeting to Mr. Antwan Nelson, Project Coordinator, Orange County (OC) Neighborhood Services Division.

- Youth Sports Enhancement Grant Overview –Mr. Antwan Nelson, Program Coordinator, OC Neighborhood Services Division gave an overview of the Ocoee Bulldogs grant application and funding request.
