- VI. Manager's Update (Projects, Issues & Section Updates) Matt Suedmeyer, Manager
 - o Infographics Mr. Suedmeyer presented a presentation on Infographics and the current situation within Orange County. Following a brief overview, followed by discussions and board input, no further action was taken by the board.
- VII. Parks & Rec Division (Section Updates)
 - Operations Kyle Kent, Assistant Manager Mr. Kyle Kent updated the board on the Parks and Recreation current hiring
 process and situations that impede many individuals from getting hired and/or finding other employment prior to the completion
 of required background checks, etc. Following a brief discussion, no further action was taken by the board.
 - Planning & Design Section Update Mrs. Regina Ramos, Project Manager Several projects were highlighted and following a brief discussion, no further action was taken by the board.
