- \*purchasing of the Royal Place apartments
- \*purchasing of the Clarion apartments
- \* purchasing of the 5404 Silver Star Rd. bank (vacant)
- \*encouragement of Orange county to purchase and aggregate land on Pine Hills Rd.
- \*rezoning of Pine Hills rd. to allow for larger scale development
- \*creation of OZ website for easy navigation for interested investment firms
- \*look for opportunities to work with CDBG program
- \*host a workshop with tax attorneys to explain legal requirements of participation in program
- \*schedule site tours with interested fund groups
- \*wok on marketing and branding to appeal to fund groups
