Burns motioned to uphold classification as Dangerous, second by LaRusso. Vote on the motion is held and passes (5 to 1). Cavagnaro opposed. Brady remains classified as Dangerous.

Chair opened case 19-19835/19-17938 on appeal for dog, Bama, owned by John Hurst III.

Chair allowed John Hurst III to make a statement. LaRusso questioned if the Amazon delivery was an error. John Hurst III responded no. John Hurst III questioned previous cases involving Bama, specifically forensics. Caraballo responded Animal Services does not do forensic analysis. Animal Services has statements and Hurst III has received citations in the past. Chair explains the Board is there to base the classification on the current case, not previous cases. Chair asked the Board if they have any questions. Cavagnaro questioned Hurst III regarding if Bama lives outside. Hurst III responded yes, Bama lives outside. Chair asked Hurst III if he witnessed the incident. Hurst III responded no. John Hurst III made a statement. Sears asked Hurst III how does the electric fence work? What the perimeter of the electric fence is? Was the Bama wearing the collar at the time? John Hurst III responded. Chair made a statement. LaRusso made a statement. Deputy Martin made a statement. Hurst III stated Bama was trained. Deputy Martin questioned Hurst III where did Bama get trained? Hurst III responded he trained Bama. Deputy Martin asked where Hurst III received his training. Hurst III stated he is not trained to shoot a fire arm, but he's really good at it. John Hurst III made a statement. Chair addressed FL State Statutes. Caraballo addressed Sears regarding electric fence. Meeks explained dogs can go through electric fence and when people come to the home, they have a reasonable expectation of safety. Sears question Hurst III where the victim was parked. Hurst III responded. Deputy Marin questioned where the monitor was located. Hurst III responded. Chair motioned for the Board to vote. Chair requested a motion to be made. Deputy Martin motioned to uphold classification as Dangerous, second by Cavagnaro. Sears opposed. Vote on the motion is held and passes (5 to 1). Bama remains classified as Dangerous.
