Minutes

• Ms. Gendron opened the meeting thanked everyone for attending.

Presentation – Paratransit and Mobility

- Ms. Gendron introduced Ms. Johnson and Ms. Numpe with Lynx.
- Ms. Johnson and Ms. Numpe provided an overview of the paratransit system operated by Lynx. This system provides 24/7 services to Orange, Osceola and Seminole counties. This non-emergency "ride share" program requires clients book appointments no later than the day prior to the appointment. Emergency, same day appointments are not available.

- Access Lynx serves individuals who cannot ride the normal bus service. An application
 process is required and there are two programs that individuals can qualify under, including
 Americans with Disabilities (ADA) or Transportation Disadvantaged (TD). Medical trips in
 the state of Florida are provided through the Medicaid Advantage Plans.
- Lynx has contracted the Access Lynx program to MV Transportation. On average, this system provides 50,000 trips per month. (A trip is one way, not round trip.) The average trip time is 90 minutes to two hours. Drivers have a 30-minute window to pick up a client. If a client is not ready for pickup, the driver is only permitted to wait for five minutes.

Commission on Aging Update

- Ms. Gendron polled the Committee on whether to keep the meetings at the Pine Hills Community Center in 2019 or to move the meetings to the Holden Heights Community Center. The Committee elected to keep the meetings at the Pine Hills Community Center.
