Minutes

• Ms. Gendron opened the meeting thanked everyone for attending.

<u>Crisis Intervention Team (CIT) Training Presentation</u> - Sargent Brace and Deputy First Class Thomas Martin with the Orange County Sheriff's Office

- Sargent Brace and Deputy Martin provided an overview of the CIT program, which
 began in Memphis Tennessee in the 1980's and has spread internationally. The focus of
 the program is to teach sworn law enforcement officers how to identify (not diagnosis)
 someone in crisis and then how to keep the person safe and connect them to
 community resources. In Orange County, the mental health resources include the
 Central Receiving Center, Aspire and the Baker Act process. Transportation to a hospital
 is another option.
- The 40-hour CIT training program covers mental health, substance abuse, suicide, autism and dementia. The national model allows for specialized training based on community need. In Orange County, an additional eight-hour training on children's issues is offered.
- The CIT unit at the Orange County Sheriff's Office includes 30 deputies. In additional, all sworn deputies have attended a presentation on the CIT program.
- Attendees were encouraged to let their clients and friends know that they could request a CIT officer when calling 911 when a crisis was present.
- In 2016, the Orange County Sheriff's Office had 10,777 mental health service calls and 155 CIT responses. In 2017, there were 9,687 mental health calls and 244 CIT responses.
