**Noel Busch-**Commented on the growing tires at the tire shop at the Northeast corner of Belco and Silver Star Rd. Would also like traffic counts to be done on Powers Dr. to address the traffic that is backed up over a mile during peak times.

**Jeff Reine**-Gave an update on the Lynx transfer station. The plan is in the County development review stage.

#### **Old Business**

### -Opportunity Zones

The board would like to recommend that the Advisory Council member Wanda Phillips lead a committee on marketing OZ's in the Pine Hills community. The county is still working with GIS to create an online mapping link that interested investors could see where the boundaries exist. The board has also asked the NID revisit the idea of land banking. The first property the board would like the NID to pursue is the old fire station located on Pine Hills Rd.

-NID and Neighborhood Services staff will be attending the march 22 meeting at the West Orange Chamber to discuss Opportunity Zones.

### Power's Drive Mural Issues

- -Artists were invited to the Pine Hills Community Council meeting to explain what they are painting on the Powers Drive side of the concrete block wall at TRS, 6330 Silver Star Rd.
- -Artists have submitted sketches to show what else will be painted on the wall.
- -Board would like the NID to continue to work with the owner for future sketches on the wall.

# -Advisory Council

-Tim Haberkamp's reappointment to the NID advisory board was approved by the Board of County Commissioners on Feb. 26, 2019.

# -Hawthrone Park Senior Housing

Wendover Housing's application was the winner of funding at the state level but cannot proceed with the project at this time.

-Due to a lawsuit by a competing developer in the City of Orlando, the case is still tied up in court and could be for atleast another 6 months.

### -Orange County Summer Youth
