OLD BUSINESS

TDT Grant Application Review Committee (ARC) - Terry Olson and Sara Segal reported on the five organizations that were recommended for funding from this committee and the Tourist Development Council.

NEW BUSINESS

Cultural Facilities Funding – FY19 award recommendations were made upon a motion by Rick Richbourg and second by Keith Smith. The Cultural Facilities Review Panels' recommendations were unanimously approved for presentation to the Board of County Commissioners on April 23:

- a. Orlando Ballet, \$483,095
- **b.** Arts & History Museums Maitland, \$26,186
- c. Orlando Science Center, \$275,192
- d. Orlando Shakes, \$31,592
- e. Downtown Arts District, \$78,951
- f. Girls Scouts of Citrus Council, \$288,585
- **g.** Pine Castle Historical Society, \$57,600

Sunset Review. Terry Olson presented questions from the Mission and Membership Review Board (MMRB) which is required to evaluate each Advisory Council at certain times to make sure that each Advisory Council is still needed and to review any needed changes in the founding resolution.

The Council discussed suggesting a change from 3% to 6% of the first four cents of the Tourist Development Tax, including the rationale for increased funding that United Arts has put together with a comparative study of funding from other counties, a list of the many organizations that would benefit as well as a few minor changes in the committees of the Council and a couple other technical adjustments. Hal Kantor suggested that a listing of more accomplishments of the Council needs to be included. Upon a motion by Sara Segal and second by Rick Richbourg, the Council unanimously approved the direction as stated above and authorized Rick Schell and Terry Olson to make needed changes to submit to the MMRB.

Director's Report

Terry pointed out that the Council is going through the biggest change-over of members since it was formed in January 2002. His budget request for the following year includes the resolutions of the Arts and Cultural Affairs Advisory Council and Public Art Review Board for new staff – increasing from 2.5 employees to four full-time employees. He also requested funding for Cultural Planning.

Next Meeting

Terry Olson proposed an earlier start time for all future Council meetings to better accommodate some members availability, and changed the meeting time to 8 a.m. All present agreed.

Meeting was adjourned at 10:05 a.m.
