Orange County Citizens' Review Panel Advisory Board for Human Services Allocation Meeting for FY 2019-2020 January 30, 2019

Citizens' Review Panel (CRP) Vice Chairperson Dr. Beena M. Parikh welcomed everyone to the Allocation Meeting. Members of the public were not present for comments.

Dr. Beena M. Parikh opened the board up for discussion regarding the modifications done to the Citizens' Review Panel process. Panel members discussed their experiences with the Citizens' Review Panel process and praised CCC staff for their support and responsiveness during the process.

Dr. Beena M. Parikh communicated to the board that additional funding designated for children services, per Mayor Demings' announcement, will be allocated through the CRP. The board will be expected to reconvene in the near future to allocate funding that will become available to the Community & Family Services Department for fiscal year 2018-2019. CCC staff disclosed to the

CRP board the most current information available regarding the additional funding for fiscal year 2018-2019.

Minutes for the 2019-2020 CRP Kickoff meeting and Panel Review Sessions were reviewed by panelists. Janice Battle-Brinson made a motion to approve the minutes; Joey Barnes seconded the motion. All were in favor.

After a funding briefing by Charise Liburd, Sr. Program Manager at the CCC, the panel discussed funding recommendations.

Vice Chairperson Dr. Beena Parikh discusses the allocation process.

CCC staff read the preliminary funding spreadsheets and received the CRP's recommendations from Panel 1 – Lending a Helping Hand, and Panel 2 – Building Thriving Communities.

CRP Preliminary Funding Recommendation

Vice Chairperson Dr. Beena M. Parikh proposed that Orange County CCC staff be able to make any adjustments to the recommendations for errors (such as mathematical adjustments). Vice Chairperson Dr. Beena M. Parikh also opened the floor for discussion regarding a final motion to accept all recommendations.

After general discussion regarding the request for additional funding by renewal agencies, the CRP Panel proposed a process for how to distribute additional funding if available.

Sasha Watson clarified that the following motion for additional fund distribution will not be the precedent for future funding allocations.

Motion by Willie Patterson to approve current available funding and recommend an increase of 2 percent for all renewal agencies requesting up to 2 percent if funds are available. All other renewal agencies requesting more than 2 percent are to be capped at a maximum of 10 percent if funds are available. If funds are not available to meet the 10 percent maximum, then those agencies will receive increased funding at a prorata percentage. Agencies include Pathways Drop-In Center, Inc., Community Health Centers, Inc., Heart of Florida United Way, Inc., Orlando Health, Inc., dba The Howard Philips Center for Children & Families, and Volunteers for Community Impact. Motion also to include that Orange County CCC staff be able to make any adjustments to the recommendations for errors (such as mathematical adjustments); seconded by Betsheell Louis. All were in favor.

The Vice Chairperson asked that all funding recommendations be kept confidential and reviewed the appeal process for agencies.

Election for Vice-Chairs for FY2019-2020

Dr. Beena Parikh will serve as Chair for the 2020-2021. Dr. Beena Parikh opened the floor for nomination of the vice chair.

- Motion was made by Willie Patterson to nominate Dr. Tyon Hall as Vice Chair; seconded by Kinda Haddad. All were in favor.
- With no other nominations, Dr. Tyon Hall accepted the incoming Vice Chair position.

General Discussion and Evaluation

Vice Chair Dr. Beena Parikh opened the board for general discussion. The CRP board gave feedback to the CCC staff regarding the implementing software for the CRP fund distribution process. The CRP panel members agreed that paper copies should be available, only if requested by board members.
