#### **Minutes**

• Ms. Gendron opened the meeting thanked everyone for attending.

#### **Medicaid Eligibility** – Kathleen Flammia, Flammia Elder Law Firm

- Ms. Flammia provided an overview of Medicaid eligibility. She state individuals must meet three types of qualifications, including basic eligibility, medical criteria and financial criteria.
- Ms. Flammia reviewed the Florida Department of Children and Families' ACCESS portal.
   Individuals interested in applying for Florida Medicaid must complete an application on the ACCESS portal.
- Ms. Flammia stated the application process for Florida Medicaid is a complicated and structured process. Medicaid has a right to "look back" at five years' worth of income and assets distributions. Individuals who fail to disclose all income and assets or do not comply with "draw down" regulations are subject to penalty.
- Ms. Gendron thanked Ms. Flammia for the presentation. She added that an elder law attorney has been trained to understand the Florida Medicaid process.

- Ms. Gendron, Alzheimer's & Dementia Resource Center Ms. Gendron stated their website
  includes a comprehensive list of the trainings and educational programs available to
  caregivers.
- Ms. Austin, Florida House District 46 Ms. Austin stated the Florida Legislative Session ends this week. She will forward new laws and updated laws to the Office on Aging for distribution.
- Ms. Talbot, Winter Garden Senior Home Care Ms. Talbot provided an overview of the Medical Equipment Bank, the Painting a Memory program and the Musical Minds Choir that are all located in the Winter Garden community.
- Ms. Monroe, Cornerstone Hospice Ms. Monroe stated Cornerstone is hosting a training for case managers on depression, dementia and the Baker Act process on May 9 from 9 a.m. to 12:30 p.m. Social workers can receive three CEUs for this free training.
- Ms. Alexander, Florida Department of Health in Orange County Ms. Alexandra commented the state of Florida has been recognized as an "age-friendly" state. Her office has just started funding Fit to Dance 2 for exercise classes at four senior locations in Orange County.
- Ms. Baily and Ms. Hartman, United Health Ms. Baily and Ms. Hartman stated United Health has launched a "Renew Active" program that provides fitness classes and active aging education to their members.
- Ms. Gavagan and Ms. Maley, FUNctional Independence Training The next eight-week falls prevention class will be held in September at the Center for Independent Living. Staff is also conducting trainings at several assisted living facilities.
- Ms. Knight, Florida Office of the Attorney General Ms. Knight introduced herself as the new liaison on identity theft, fraud and scams. She can do presentation in the community.

- Ms. Waters, AdventHealth Hospice Ms. Waters stated AdventHealth Hospice has a new cardiac care program that can be implemented in any residential setting that a person lives.
- Ms. Allen, PCAN Ms. Allen stated funding for the PCAN navigators has been reduced. There are now only four navigators.
