 - Jan Clanton reported that all the money allocated for this committee has now been approved for disbursal through FY2024. The committee will meet quarterly. Commissioner Bonilla is seeking appointment of someone to replace Jan Clanton.

Terry Olson reported on the changes the Arts and Cultural Affairs Advisory Council has presented to the Membership and Mission Review Board because of the coming Sunset Review. While that process moves forward others will be having conversations with top community leaders.

- d. Cultural Plan
 - Terry Olson reported that he has requested funds in the 2019-20 budget for a cultural plan, likely to be matched with some private funds.
- e. Sustainability Plan

A newly formed Advisory Council Sustainability Committee was formed and will work on changes.

f. State of the Arts

Terry will give the annual State of the Arts address at the 2 pm meeting of the Board of County Commissioners on July 2.

2019-20 State of Florida, Division of Cultural Affairs Arts Funding – Budget Appropriations; budget approved by Governor DeSantis – June 20, 2019

\$21,250,028 in APPROPRIATIONS APPROVED under the Florida Department of State (DOS) Division of Cultural Affairs (DCA) in the FY 2019-20 State budget for three of the four DCA matching-grant categories:

- \$2,980,028 fully funds all 132 <u>Culture Builds Florida Matching Grants</u>
- \$12,300,000 for <u>Cultural and Museum Matching Grants</u> (provides approximately 29% of each of the 478 recommended grant amounts)
- \$5,970,000 for <u>Cultural Facilities Matching Grants</u> (funds first 18 on ranked list and partially fund #19 of 37 recommended grant amounts)

Talk points for chart, State of FL, DCA's 6-year funding history (on reverse):

- ✓ From \$2.65M last year to \$21.3M this year!
- ✓ This budget allocation brings Florida from 48th place, back up to 20th in the nation, in state arts funding.
- √ The FY20 State of FL arts funding through DCA represents 49% (half) of the full-funding year FY15 at \$43M
- ✓ Funding is 1/3 of this year's total recommended \$61.7M (34.5%)
- √ 8 times more than last year, in total

✓ Summary statement:


State arts funding is on the rebound: Increased from \$2.65M to \$21.3M for FY20, at 8 times more than last year and 1/3 of eligible recommendations for FY20. Florida state arts funding is up to 1/2 of FY15's \$43M level of support.

 We are so thankful for increased funding, but need to continue to work to restore arts support to the FY15 level of \$43M.

In our region, the funding from state of Florida for DCA matching grants will provide:

- Orange County \$2,177,407 of \$5,382,407 (40% on average) in 29 awards:
 24 Culture & Museum Grants, 2 Cultural Facilities Grants, 3 Culture Builds Florida Grants
- In the Cultural & Museum Grant category On a request/recommendation for \$150,000, the grantee could receive \$43,500 (on average of 29% of request; actual based on ranking iteration)
- UA four-county service area (Lake, Orange, Osceola and Seminole counties) received the following FY20 State Arts Funding from DCA: \$2,521,177 of
 \$7,382,307 (34% on average) in 45 awards.
