PUBLIC SAFETY

Westgate Plaza Concerns:

- This property's parking lot has been repaired.
- The NID will partner with The Wire radio station again this year for a business focused National Night Out event on Oct. 1 in the parking lot of 6001 Silver Star Road
- A pedestrian safety blitz is scheduled for Oct. 15 in partnership with UCF, FDOT and Orange County Transportation Planning.

OCSO Initiatives:

- Deputy Audra Norwood is working with Code enforcement to address lot removal of the homeless gentleman's belongings that has been located on Silver Star for the last several weeks. He has been trespassed from the bus stop in front of it, but still remains in the lot. He's even been to jail a few times for trespassing, but has returned.
- The NID is working with Evans High School to come up with a code of conduct for students as they enter area businesses during dismissal. We are also working with Captain Tony Marlow to adjust our off duty patrol times so that they can be worked during peak need hours in the corridor.
