I. Call to Order

With a quorum present, Vice Chair Frances Guthrie called the meeting of the Lake Conway Water and Navigation Control District Advisory Board (Advisory Board) to order at 6:30 p.m.

II. Approval of the June 9, 2020 Meeting Minutes

Upon a motion by Micky Blackton, seconded by Elizabeth Nelson, and carried with all present members voting AYE by voice vote, with Gary Meloon being absent; the Advisory Board approved the June 9, 2020 meeting minutes.

III. Public Comment on Propositions before the Advisory Board

V. Orange County EPD Report

Advisory Board Meeting Time

The Advisory Board was given the option of changing the start time of the virtual Advisory Board meetings. A general consensus was 6:00 p.m. would be the earliest to start the meeting.

Annual Routine Services

Lake Conway Water and Navigation Control District Advisory Board Meeting Minutes July 8, 2020

Ms. Urbanik presented a spreadsheet with the proposed routine services for next fiscal year. A request for an increase in the gatekeeper daily rate from \$8.00 per hour to \$10.00 per hour was proposed. The Advisory Board agreed on increasing the gatekeeper daily rate.

Upon a motion by Bobby Lance, seconded by Micky Blackton, and carried with all present members voting AYE by voice vote, with Gary Meloon being absent; the Advisory Board approved up to \$334,679.00 for the annual routine services for the 2020-2021 fiscal year.

Lake Gatlin Alum Treatment Proposal Update

A previous lake study was conducted in 2002 to warrant the alum treatment in 2004. Ms. Urbanik has been in contact with the consultant to locate the last report, and she will request a smaller scope of service to accomplish a future alum treatment.

Lake Conway Stormwater Study Update

A discussion was held regarding the option to hold a virtual meeting for the Lake Conway Stormwater Study community meeting. Commissioner Uribe stated Governor DeSantis is extending the virtual meeting allowance on a month to month basis, and she would prefer to see the community meeting in person, but does not want to delay the meeting if current health safety conditions were to continue. A general consensus by the Advisory Board is to prefer an in-person meeting, but they are amenable to a virtual meeting if necessary.

Mr. Blackton inquired on the process to increase the Lake Conway MSTU (Multiple Service Taxing Unit) taxing district millage rate. Discussion ensued.

Upon a motion by Bobby Lance, seconded by Micky Blackton, and carried with all present members voting AYE by voice vote, with Gary Meloon being absent; the Advisory Board approved setting the community meeting for the Lake Conway Stormwater Study meeting during the October 13, 2020 regularly scheduled Advisory Board meeting, with the continued discussion on the MSTU millage rate.

Aquatic Plant Management

Ms. Urbanik stated the County is re-evaluating the *Lyngbya* spp. treatments on the Finger Canals. Periodic low dissolved oxygen (DO) levels in the canals have been reported to cause fish kills that affect smaller fish that are more sensitive to drops in DO.

The Lake Jessamine Advisory Board has approved a scope of services for a lake study, which will eventually result in an alum treatment that will indirectly have a positive effect on the Conway Chain of Lakes.

VI. Marine Patrol Report

Ms. Urbanik presented the marine patrol report. For the month of June 2020, the following activities were reported:

- 13 vessel citations
- 90 vessel warnings
- 32 vessel inspections

VII. Lake Conway Water Elevation Report

Lake Conway Water and Navigation Control District Advisory Board Meeting Minutes July 8, 2020

David Woods presented his water elevation report. The Conway Chain of Lakes received 12.43 inches of rain in the last month. The National Oceanic Atmospheric Administration (NOAA) is forecasting high rainfall for the next couple of months.

VIII. Advisory Board Member Report

- Vice Chair Frances Guthrie: No comment.
- Bobby Lance: Mr. Lance stated the off-duty patrol is doing a great job. He also has a concern of the accelerated shoreline erosion from wakeboats. Discussion ensued.
- Micky Blackton: No comment.
- Elizabeth Nelson: Dr. Nelson described the recent studies of the lake that reference possible septic and/or sewage leaking into the lake. She stated that medical professionals are finding that COVID-19 affects the gastrointestinal tract prior to affecting the respiratory tract, and it may be possible to track the next COVID-19 outbreak based on the data from sewage sampling, resulting in her concern that the lake may pose a health risk.

IX. Non-Agenda Items

Commissioner Uribe stated she would keep the Advisory Board updated on Lake Conway concerns.
