I. Meeting Called to Order:

With a quorum present, Chair Lionel Robbins called the meeting of the Lake Holden Advisory Board (Advisory Board) to order at 5:32 p.m.

II. Approval of the July 15, 2020 Meeting Minutes:

Upon a Motion by Mike Powell, seconded by Caroline St. Clair, and carried with all present members voting AYE by voice vote; the meeting minutes for July 15, 2020 were approved as submitted.

III. Public Comment:

Rhea Cammenga stated she has been following recent meetings of the Butler Chain of Lakes and Lake Conway Advisory Boards in relation to no wake zones, an uptick of jet skis, speeding, and other boating safety issues. She inquired about the possibility of a boating safety zone around Lake Holden's island. Discussion ensued.

No one from the public arrived in person at the EPD office to present public comment. Likewise, no written public comments were submitted. Hearing no further requests, Chairman Robbins closed the public comment period.

IV. Environmental Protection Division (EPD) Report:

Environmental Research & Design (ERD) Water Quality and Sediment Evaluation

Melissa Lavigne provided the following project update:

Progress Report #4 for work efforts June 1 to July 30, 2020

1. \$15,469.60 this billing period; \$51,925.94 total billed to date out of \$101,161.56 project total.
2. Update/Evaluate Water Quality Trends: water quality data for Lake Holden have been downloaded and updated, and trend analyses are being conducted (50% complete).
3. Internal Recycling: sediment incubation and sample collection, and incubation under aerobic and anoxic conditions has been completed (100% complete).
4. Review/Revise Sub-basin 13 Watershed: Pegasus Engineering continues on this task.

Aquatic Plant Management Update

Melissa Lavigne reported that quarterly surveys are scheduled to begin next week, and grass carp addition is still slated for the fall.

Outfall and Development Updates

29th St Outfall at 500 29th St: Melissa Lavigne contacted the City of Orlando to inquire about possible maintenance dredging. The Streets and Stormwater Division evaluated the area to see if the City could handle the project. The response was that their equipment is too heavy to access the area. The excavator could damage the pipe that sits on top of the ground, so they are unable to assist with the Advisory Board's request to remove the sandbar.

Paseo Ave Outfall at 600 29th St: Melissa Lavigne received a quote from the County's Aquatic Restoration and Plant Management contractor. The cost proposal for clearing the easement is \$6,288.90. Discussion ensued.

Upon a Motion by Mike Powell, seconded by Caroline St. Clair, and carried with all present members voting AYE by voice vote; the Advisory Board approved the expenditure of MSTU funds not to exceed \$8,000 to clear vegetative growth and debris from the Paseo Avenue stormwater outfall located near 600 29th Street.

SoDo House on the Lake:

Melissa Lavigne stated she received several citizen inquiries about SoDo House on the Lake, a proposed development on the north end of Lake Holden near 29th St. and Michigan Ave. The City of Orlando's Planning Division responded that current plans do not show any ramp or dock structures leading from the property towards the lake. Tasha Golis, Lake Holden Property Owners Association President, has been actively communicating with the City on this development.

Water Atlas Update

Melissa Lavigne mentioned the Orange County Water Atlas has been recently updated and has a new and improved look. She encouraged everyone to explore Lake Holden's page, as well as the other resources available on the site.
