**I. PUBLIC COMMENTS**

- A. The meeting was called to order at 12:03 p.m. John M. Crossman, Chairman, opened the meeting for public comments.

No public comments were received.

**III. NEW BUSINESS**

**A. Public Hearings**

**1. Housing Choice Voucher Program (Section 8) 2020-2025 Five-Year Plan and 2020 Annual Plan**

The public hearing opened for comments.

Olivette Carter, Program Development Supervisor, reported on the Housing Choice Voucher Program (Section 8) 2020-2021 Five-Year Plan and 2020 Annual Plan. More specifically, Ms. Carter reviewed the goals and objectives

associated with the Five-Year Plan that enable the County to serve the needs of low-income, very low-income, and extremely low-income families for the next five years. The Program goals included increasing the availability of decent, safe and affordable housing; promoting self-sufficiency and asset development among program participants; and maintaining high standards in the management of all program components.

For the 2020 Annual Plan, Ms. Carter stated that Orange County has 1,263 regular vouchers, with 1,235 of them being utilized (a rate of 98.2%). The County also has 65 Veterans Affairs Supporting Housing (HUD-VASH) program vouchers of which 57 are utilized. In addition, Orange County administers 50 vouchers for the Mainstream Program – a new program from HUD.

Ms. Carter also reported that the Section 8 waiting list has closed with 14 pending applications and 330 people on the waitlist. Ms. Carter proceeded to answer several questions from the Board members related to the high cost of housing, COVID-19 and their impact on the Section 8 program.

### 2. 2020-2021 One-Year Action Plan

The public hearing opened for comments.

Ms. Souvorova provided an overview of the FY 2020-2021 Action Plan timeline and continued with an overview of a summary worksheet with the proposed funding for the Community Development Block Grant (CDBG) and Emergency Solutions Grant (ESG) applications received by Orange County as part of the FY 2020-2021 Request for Applications (RFA) process.

Ms. Souvorova noted that the public comment period for the Action Plan started on June 15, 2020 and will end on July 17, 2020, after which date the Action Plan will be finalized and submitted to the Board of County Commissioners (BCC) for approval.


