Ms. Souvorova, reviewed a summary of the affordable housing activities, community development accomplishments, and homeless services implemented during Fiscal Year October 1, 2019 and September 30, 2020. Ms. Souvorova also reported on the progress made to date with the supplemental CDBG-CV and ESG-CV funds that have been allocated to help prevent, prepare for, and respond to the coronavirus pandemic (first round of allocations, with subrecipient agreements executed in September-October of 2020).

During the February 2021 meeting, the CDAB will discuss the COVID related projects submitted as part of this RFA process.
