The motion was seconded by Jeff Loeffert., all six (6) agreed – 1 opposed (Joey Kraft). Motion passed.

- Youth Sports Criteria Jeff Loeffert, District 1 Representative, gave a very detailed overview of his findings and suggestions relating to field usage by some of the league teams that use the ballfields at the various OC Parks.
- Field Allocation Process Jeff Loeffert recommended a motion to extend the contract for one (1) year and to invite Commissioner Wilson to present her concerns to the board. The motion was seconded by Dewey Harvey. All agreed – none opposed. Motion carried.
- Tree Memorial Request Robert Alex Eriov the board was presented with the necessary information needed to approve a

 Parks Division for approval, Chairman Arias called for discussion by the board no discussion and a motion for approval was
