**I. Call to Order:**

With a quorum present, Rabon (Ray) Vause called the meeting of the Lake Conway Water and Navigation Control District Advisory Board (Advisory Board) to order at 6:30 pm.

**II. Approval of the June 14, 2016 Meeting Minutes**

**Upon a motion by Micky Blackton, seconded by Bobby Lance, and carried with all present members voting AYE by voice vote, with Steve Udouj being absent; the Advisory Board approved the June 14, 2016 minutes as presented.**

**III. Public Comment on Propositions before the Advisory Board**

There were no public comments.

**IV. Comments of the Chairman**

Chairman Vause stated the lake looks good and the water temperature is warm. Bobby Lance stated Lyngbya has begun to pop up in the Daetwyler Lagoon. Chairman Vause welcomed the University of Central Florida students and asked they introduce themselves.

**V. Water Sports Industry Association Presentation**

Kevin Michaels, the Executive Director of the Water Sports Industry Association (WSIA), gave a brief description of the focus of the WSIA and offered his expertise with answering questions. Discussion ensued and Mr. Michael's provided information regarding towed water sports, recommended boating etiquette and environmental concerns. The Towed Water Sports Handbook, a publication of the WSIA, was distributed to the Advisory Board. Officer Tren Trendafilov answered questions related to public safety and setbacks from shoreline and dock structures.

**VI. Marine Patrol Report**

Ms. Urbanik has sent out bid proposal requests for the navigation marker installations. The previously discussed duck hunting concern is currently being reviewed by the County Attorney's Office.

Firearms signage is proposed to be installed at the Ferncreek Avenue and Randolph Avenue boat ramps and Warren Park. Once the signs are created, Ms. Urbanik will notify the Advisory Board.

**VII. Old Business**

**1) Aquatic Plant Management**

Ms. Urbanik proposed a cost share opportunity to the Advisory Board, and asked if there is interest with partially funding aquatic plant restoration or a berm and swale project at a private residence. The Advisory Board requested Ms. Urbanik research how the Lake Gatlin restoration project was funded and requested information on what other Lake Advisory Boards have in place for these types of cost share projects.

**2) Street Sweeping and Curb Inlet Basket Reports**

Ms. Urbanik stated she provided an informational street sweeping statement to the City of Belle Isle for distribution to their E-Alert. Bobby Lance stated the street sweepers have slowed down their speed while sweeping the neighborhoods.

**3) Conway News Article**

It was requested an article from the Towed Water Sports Handbook be provided for the next news article. Mr. Michaels offered his assistance with providing an article.

**4) Lake Conway Stormwater Management Study Update**

Ms. Urbanik provided a handout of the current Study status.

**5) Canal Dredging**

Ms. Urbanik inspected the stormwater inlet location. The grate inlet locations do not meet the minimum 24 inch requirement to accommodate a grate inlet basket.

**6) City of Belle Isle Stormwater Outfall Maintenance Dredging**

The quote to restore the shoreline back to original grade has not yet been received. The Advisory Board discussed the safety concerns of the outfall pipe within the Lake.

**7) Story Maps**

No update provided.

**VIII. New Business**

No new business was discussed.

**X. The Lake Conway Water Elevation Report**

David Woods provided the Elevation Report, discussion ensued.

**XI. Non- Agenda Items**
