I. Call to Order:

With a quorum present, Rabon (Ray) Vause called the meeting of the Lake Conway Water and Navigation Control District Advisory Board (Advisory Board) to order at 6:33 pm.

II. Approval of the October 11, 2016 Meeting Minutes

Upon a motion by Bobby Lance, seconded by Jay Herrington, and carried with all present members voting AYE by voice vote; with Micky Blackton being absent, the Advisory Board approved the October 11, 2016 minutes as presented.

III. Public Comment on Propositions before the Advisory Board

IV. Comments of the Chairman

Chairman Vause stated the lake looks great and there appears to be less personal watercraft activity at night.

V. Marine Patrol Report

Sergeant Parker provided an update of the off duty patrol report. Discussion ensued regarding the continuing use of personal watercrafts at night. Sergeant Parker suggested the off duty reporting template be revised to clearly state the applicable law enforcement activity conducted on the lake. The Advisory Board discussed what information they would like to see on the off duty report. The Advisory Board requested off duty presence for the upcoming Lake Conway boat parade on December 16-18, 2016.

1) EPD Report

Ms. Urbanik stated she spoke with the representative from the Neighborhood Preservation & Revitalization Division, resulting in the understanding that the Lake Conway East Homeowner Association is eligible to apply for the lakeshore restoration grant.

The curb inlet baskets under warranty are in good condition. The Advisory Board will be notified what other baskets will need to be repaired or placed. Ms. Urbanik discussed the details of the recent aquatic plant survey and discussed the resulting aquatic plant treatment from the survey. Ms. Urbanik stated *Lyngbya* has been noted at the Lake Anderson outfall pipe on the north east lobe of Little Lake Conway and near the cove of the Gatlin canals.

3) Lake Conway Stormwater Management Study Update
