**Revised Bid Opening Date: October 23, 2014 at 2:00 P.M.**

This addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to, and shall take precedence over, the original documents. Underlining indicates additions, deletions are indicated by ~~strikethrough~~.

A. The bid opening date is changed from ~~October 21, 2014 at 2:00 P.M.~~ to October 23, 2014 at 2:00 P.M.

B. **Failure to use the attached Revised Page D-2, bid form will result in your bid being found non-responsive and ineligible for further consideration.**

C. Additions, Deletions and Clarifications:

1. **Question:** The geotechnical report notes the presence of highly organic (muck) soils in the area of the work. Previous projects on this park site encountered unsuitable soils. It is not possible to accurately price the work related to the removal and replacement of unsuitable soils that may be encountered. The removal and replacement of unsuitable soils is typically handled with a specified quantity to be included in the base bid, and a unit price to make adjustments to the contract as necessary once actual field quantities are determined: If more unsuitable soils are encountered, the contract amount is adjusted higher; if fewer unsuitable soils are encountered, the contract amount is adjusted lower. Please advise as to what quantity (if any) of unsuitable soils are to be included in our base bid.

**Answer:** Upon further review of the geotechnical report. Most of the demucking in the report is concerning the restroom building that we are no longer building. Boring 2 has peat from 1.5 to 5 feet below grade. This is near the ditch that goes through the west side of the new field. We are adding between 1-2 feet of fill in this area to meet grade. So there is a low chance that muck will need to be removed. Furthermore, we are building a playing field and not a building. With that being said there is a history of muck on the site and a lot of muck was removed with the construction of the new gym building. The field size is 225 x 330 which is 7,425 SF. Assuming average muck removal of 1-ft over the field that yields 2,750 CY of muck to be remove and clean fill to be brought in.
