**DEDUCTIVE BID ITEM 001:** The base bid includes all non-field areas to be sodded with Bahia sod. This deductive bid item is to hydroseed that portion of the site identified on the landscape plan sheet L1 as allowing hydroseeding.

**DEDUCTIVE BID ITEM 002:** The MUSCO light poles, MUSCO light fixtures and the associated controllers will be removed from the project if deductive bid item 002 is accepted. The conduit running from the electrical panel to the light poles is to be installed and is not part of this deductive bid item. The conduit ends are to be capped and marked with metal caps so they can be easily found. The wire inside of these conduits is not being installed. Electrical needs and the controller for the irrigation system as shown on Sheet E-1S are still included and are not being removed by this deductive bid item
