The following are questions, with respective answers, for the above IFB:

1. QUESTION – Citrus and Healthease are no longer Medicaid managed care plans according to AHCA: http://www.floridahealthfinder.gov/HealthPlans/Compare.aspx?typcd=MRC

ANSWER – If a referred child has any of the two insurance plans, Head Start would have to cover the expenses related to services.

2. QUESTION – We are not in network with Staywell. Would that cause any bid by us to be considered a counter offer and unacceptable?

ANSWER – All bids will be equally considered. Orange County Government has the practice to select the lowest bidder. In the event two or more bidders are equally low in cost, we need to consider the amount of insurance companies the provider is on network. Head Start is only covering children's services for those not having insurance. The more a provider is able to process fee for services through a child's insurance, the better for Head Start since federal funds are used as last resort.

3. QUESTION – Who currently provides PT/OT/ST services for Headstart?

ANSWER – Orange County Head Start is offering SL/PT/OT therapy services temporarily through a Purchase Order granted to United Cerebral Palsy of Central Florida.

ANSWER – The projection date to start the contract is towards the end of March.

5. QUESTION – How much time will there be between the award of the bid and the start date of services?

ANSWER – Please refer to answer #4. The Contract award should occur sometime in late February the services should start late March.

6. QUESTION – Will the meeting 12/2 (rescheduled to 12/12) provide answers to specific questions related to this specific bid or more general information?

ANSWER – During the Pre-bid meeting Orange County Head Start (OCHS) will provide as much specific answers as possible.

All other specifications, terms and conditions remain the same.
