If the Contractor does not have the CSP certification at time of bid opening, the Contractor shall provide documented proof that a staff member of the company is in process to receive the CSP certification and shall be certified no more than six (6) months after contract award. The CSP certification shall be submitted to Procurement upon receipt.
  - 2. Page 25, SCOPE OF SERVICES, MINIMUM REQUIREMENTS FOR **CONTRACTOR, 2.** The Contractor shall operate a 24-hour office so that key personnel can be reached in the event of emergency orders and must be able to provide laborers within two (2) three (3) hours of verbal notification in emergency situations and twenty-four (24) hours in normal situations.
