This addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. Additions are indicated by underlining, deletions are indicated by ~~striketrough~~.

**THE BID OPENING DATE REMAINS UNCHANGED.**

**1. The following represents a change to the IFB.**

Regarding Part G, Article 20, **ADD** Paragraph 6 to read as follows

- 6. BACKGROUND SCREENING** - Due to the close proximity of the project site to the Bishop Moore High School, it will be necessary for all Contractors, Sub-Contractors, Consultants, Sub-Consultants, Surveyors and County Staff to ingress and egress through the school property. School Administration Officials have requested that all proposed on-site personnel be fingerprinted and undergo Level 2 background screening through the Florida Department Of Law Enforcement (FDLE) in accordance with the Jessica Lundsford Act (Florida Statute 1012.465). Based on this requirement, all on-site personnel (including County Staff members, Consultants, Sub-Consultants, Surveyors, the County's selected Contractor and his Sub-Contractors), must agree to be fingerprinted and undergo background screening. The County's selected Contractor, his Sub-Contractors and Surveyors shall submit a list of all proposed on-site personnel in writing to the County's Project Manager within seven (7) days of written request. The County's selected Contractor, his Sub-Contractors and Surveyors shall have fingerprinting performed electronically and submit electronic background screening applications within fourteen (14) days of the County's written request. The cost of fingerprinting and background screening shall be included in the Bidders submittal and at no additional cost to the County. 2. All other terms, conditions and specifications remain the same.
