### Addendum No. 1/RFP Y15-1022-CH

### DISASTER RECOVERY AND DEBRIS REMOVAL

**Proposal Opening Date: March 17, 2015** 

This addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. <u>Underlining</u> indicates additions, deletions are indicated by <u>strikethrough</u>.

- 1. The Proposal Opening Date shall remain March 17, 2015 at 2:00 P.M.
- 2. Note the following **REVISION** to the 1<sup>st</sup> Paragraph under Instruction to Proposers, on Page 1 as follows:

Firms or companies desiring to provide services, as described in the Scope of Services, shall submit sealed proposals, one (1) original, <u>nine (9)</u> eight (8) copies and one (1) electronic copy on CD or USB drive not later than **2:00 PM local time, March 17, 2015**, to the Orange County Procurement Division, Internal Operations Centre II, 400 E. South Street, 2nd Floor, Orlando, Florida 32801, (407) 836-5635.

3. Note the following **REVISION** to the Attachment B - Fee Schedule as follows:

Delete: Attachment B – Fee Schedule, Pages B-1 through B-15 issued in the Request for Proposals, dated February 13, 2015.

Replace with: <u>Attachment B – REVISED Fee Schedule, Pages Revised B-1 through Revised B-15 issued in Addendum #1</u>.

- 4. The following are responses to questions received by interested proposers:
  - a. <u>Question</u>: Page B-1, item 1B: This shows that contractor is responsible for storing, processing, management and final disposal of debris at Citizen Sites. I explained that contractors do not normally process woody debris nor white goods delivered to the site, at the site. The statement as written requires the contractor process debris at these locations and take straight to final disposal. The only debris that will potentially be hauled straight to final disposal from the Citizen sites will be C&D that cannot be processed. Can this information be clarified?

<u>Answer</u>: Refer to the Revised Fee Schedule included in Addendum #1. Item 1B has been revised.

b. **Question**: Page 20 of the RFP talks to Marine Debris Removal, however we did not see a line item for marine debris removal or vessel removal within the pricing schedule. If those items will be part of the scope of work, will an addition be made to the pricing schedule to include these items?

<u>Answer</u>: Refer to the Revised Fee Schedule included in Addendum #1. This item has been added to Revised Fee Schedule/Other Fees on Page Revised B-14.

c. <u>Question</u>: The second paragraph on page 16 states that a contractor representative is required to report to the Orange County Emergency Operations Center within 6 hours after notification of need. Our rep was told that contractor's would not be allowed in the EOC, so will the reporting location be adjusted to a new location?

<u>Answer</u>: The Contractor will report at the Orange County Emergency Operations Center (EOC), but may be stationed/relocated to the Public Works DOC by County staff.

d. <u>Question</u>: Proposal Format – Qualifications of Firm – 4. Pg. 12: "Experience in all aspects of emergency debris management to include procurement, operation, planning, contract management and accounting systems." Can the County clarify what they mean by "procurement" and "contract management?"

<u>Answer</u>: Procurement and Contract Management are defined as an ability to demonstrate an understanding of how to document, application of pay items, the ability to manage sub-contractors (material contractors, equipment contractors) and labor. Management of payroll, scheduling, accurate accounts and invoicing tracking and tracking resources and understand general terms and restrictions outlined in the scope of services.

- e. Question: Pg. 23-24 of the RFP, the following language appears.
  - "M. DUMP/TIPPING FEES All dump/tipping fees shall be reimbursed at their actual cost with proper documentation."
  - "N. DISPOSAL OF REDUCED DEBRIS When the County requires chipping/grinding as a method of debris reduction, it is the Contractor's responsibility to acceptably dispose of the chips or mulch, at no additional cost to the County. For disposal, the chips or mulch shall be put to some beneficial use."

There appears to be a conflict as Item "M" states that all tipping fees will be reimbursed and Item "N" states that no tipping fees will be reimbursed for chips or mulch. Can the County clarify this? Is it the County's intention that all tipping fees are a pass thru?

<u>Answer</u>: Yes, tipping fees when realized are a pass through. However, chips/mulch shall not be disposed of at the landfill. Alternate disposal processes should be sought out and used.

f. <u>Question</u>: Fee Schedule, Item 1B. Citizen Site Storage Processing Management and Final Disposal: Would the County consider providing additional scope to this item? Generally this debris is transported by the Contractor from the Citizen Site area to the TDSRS. Who will manage the collection of data from citizens at the Citizen Site?

<u>Answer</u>: It will be the responsibility of the Debris Monitor Consultant in conjunction with the Debris Recovery and Removal Contractor. Refer to the Revised Fee Schedule in Addendum #1.

g. **Question**: Attachment B - Fee Schedule Section 2B Hazardous Limbs states different pricing for different sized limbs. What rate would apply if one tree has both limbs 2 inches up to 4 inches and 4 inches up to 8 inches. We request that the County consider utilizing a single rate per tree.

Answer: Refer to the Revised Fee Schedule in Addendum #1

h. **Question**: Attachment B – Fee Schedule, B-2 Is the scope for category 2A and 2B to place the Hazardous Stumps greater than 24" and Hazardous Limbs greater than 2" on the ROW after extraction, or shall they be hauled to the TDSRS.

<u>Answer</u>: They should be removed to the TDSR as specified on Page 21, Paragraph 5. The price shall include removal, loading, hauling to TDSR for further processing.

i. <u>Question</u>: RFP #Y15-1022-CH requires each bidder to provide a Litigation Statement as to any "litigation and/or judgments entered by or against any local, state or federal entity" or that it has had no such litigation and/or "entered against such entities." Is this question restricted solely to local, state or federal governmental entities or does it include any litigation and/or judgments by or with any individuals or entities?

<u>Answer</u>: The Litigation Statement on Page B-17 is asking for the proposer if applicable, to submit a summary and disposition of individual cases of litigation and/or judgments entered by or against any local, state or federal entity, by any state or federal court, during the past ten (10) years.

j. <u>Question</u>: The top row of the Attachment B, page B-6 thru B-14 Cost Proposal Forms have Hourly rate/Unit of Measure in one column and Day Rate/Cost in another column. I can assume which of the 2 items you might want for each line item but many line items can be either; is it possible you can define which of the 2 you want for each line item, so all submitters price it similarly?

<u>Answer</u>: The Proposals will be evaluated for the Fee Criteria based on Revised Pages B-1 through B-5. Having an hourly rate and a daily rate for items on Revised Pages B-6 through B-14 the County is able to take advantage of possibly reduced daily rates.

a. **Question**: The County encourages use of disadvantaged business enterprises in consideration of subcontracting needs. No scoring criteria is applied to DBE utilization. Will the County be using any DBE utilization, or lack of utilization, in proposal scoring, evaluation or tie-breaking decisions?

<u>Answer</u>: The Scoring Criteria for the Disaster Debris Monitoring Services is as follows:

b. <u>Question</u>: During the pre-bid it was mentioned that all firms are to be registered with the FDOT Equal Opportunity Office. Do large businesses need to be registered with this particular FDOT office?

**Answer**: No, that is not a requirement.

c. <u>Question</u>: Can you provide guidance on how to complete Exhibit A, Leased Employee Affidavit? We do not use an employee leasing company, and all of our employees are covered under workman's compensation provided by the company.

<u>Answer</u>: Exhibit A, Leased Employee Affidavit is applicable when an employee leasing company provides the workers' compensation coverage.

d. **Question**: Does the County currently have a Disaster Debris Management Plan that could be shared with potential bidders.

<u>Answer</u>: A disaster debris management plan will be shared with the selected contractors/consultants at the annual kick off meeting.

- 5. All other terms and conditions of the IFB remain the same.
- 6. The Proposer shall acknowledge receipt of this addendum by completing the applicable section in the solicitation or by completion of the acknowledgement information on the addendum.
