Submit your qualifications in response to this solicitation in a sealed envelope containing (1) original and three (3) copies. The list of Pre-Qualified firms resulting from this RFQ shall be valid for a three (3) year period.

Qualifications will be accepted up to 2:00 P.M. (local time), Thursday, September 25, 2014, in the Procurement Division, Internal Operations Centre II, 400 E. South Street, 2<sup>nd</sup> Floor, Orlando, FL 32801.

Submittals shall be mailed or hand delivered in a sealed envelope to the above address. Indicate the following on the sealed envelope:

The selection of pre-qualified bidders shall not restrict the County from requiring additional minimum qualifications as the County deems necessary in the Invitations for Bids for any specific project.

Record showing the firm's training and experience in right-of-way mowing including, but may not be limited to, roadside, right-of-way and slope mowing, edging, brush/plant control and removal, blowing, fertilization of turf, litter/debris and grass clipping removal and disposal and herbicide treatment.




