PURPOSE

This Request for Information (RFI) is designed to gather information only. No cost information is to be submitted.

INTRODUCTION

REQUEST FOR INFORMATION (RFI) for a FALSE FIRE ALARM BILLING SYSTEM

Orange County Fire Rescue Department (OCFRD) is an all-risk department that performs numerous functions including fire prevention, fire suppression and emergency medical services. OCFRD is the largest fire department in Central Florida and the 4th largest in Florida, with 1,177 funded positions. OCFRD has 41 fire stations, encompassing approximately 1,000 square miles with a population of over 700,000 and provides coverage for approximately 35,000 businesses.

The OCFRD responds to approximately 8,000 false fire alarms every year. Each response involves the rapid deployment of firefighters. Every false alarm exposes fire department personnel and equipment to unnecessary risks and tangible costs. A real emergency could be occurring while firefighters are dispatched to a false alarm causing needless delay in response to a true emergency.

In an effort to curb the incidence of false alarms and mitigate expenditures from responding, the Orange County Board of County Commissioners passed an ordinance which requires billing the owner of any property that experiences three (3) or more false fire alarms during any 1-year period of time. Orange County Code of Ordinances, Section 18-3 False Alarms.
