This addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to, and shall take precedence over, the original documents. <u>Underlining</u> indicates additions, deletions are indicated by strikethrough.

- A. The bid opening date remains November 13, 2014 at 2:00 P.M.
- B. Additions, Deletions and Clarifications:
 - **1. Question:** Specifications call out eight (8) foot chain link fence while drawings call out six (6) foot chain link fence, which height of fence is required for project?

Answer: Fence shall be six (6) feet high per drawings.

2. Question: Are the (4) fixture submittal sheets given on sheet E101 representative of the fixtures on sheets E201 and E202? If so, which fixture is SLD and which is SLB?

Answer:

- SLA and SLB fixtures are the same type as shown as "PARKING LOTS AND ROADWAYS" on sheet E101. SLB Fixture is a 2-head fixture of the Lithonia D-Series.
- SLD fixtures are for the "SOCCER FIELD" as noted below the MUSCO fixture submittal sheets on sheet E101. These are MUSCO fixtures.
- Finally SLC1 fixture as listed on the plan is shown for the "SKATE PARK" fixture as Lithonia KSF3 on sheet E101.
- **3. Question:** Where is the light pole spec for types SLA and SLC1?

Answer: Please refer to E501, a concrete direct burial pole.

4. Question: Sheet E301 shows (2) 4' fluorescent fixtures in the power center detail. What is the spec for these fixtures?

Answer: Please use as basis of design: Lithonia, type C, 1 lamp, T-8 fixture.

- **5. Clarification:** The paved area surrounding the restroom/storage building is to be concrete. Use 5" concrete pad per detail 15/C401. The paving should be 5' x 5' saw cut grid, expansion joints 30' on center. See Landscape Architect's plan for scoring pattern.
