Delete: Delete the last sentence that reads “This lump sum price shall not exceed 5% of ~~the total of all bid items except bid items under section 10.1 General.~~”

Add: Add in its place the following sentence: “This lump sum price shall not exceed 5% of Bid Items 2 thru 26.”

Table A, BID ITEM 4

Delete: Delete the title that reads “Reference ID 10.140.xxx Project Record Documents (a minimum of 1% of ~~the total of all bid items except bid items under section 10.1 General~~)”

Add: Add in its place the title that reads "Reference ID 10.140.xxx Project Record Documents (a minimum of 1% of Bid Items 5 thru 26)"

Table A, BID ITEM 4a.

Delete: Delete the last sentence that reads "This lump sum price shall be a minimum of 1% of ~~the total of all bid items except bid items under section 10.1 General.~~"

Add: Add in its place the following sentence: "This lump sum price shall be a minimum of 1% of Bid Items 5 thru 26."
