- c. **REVISE** Pay item description to read as follows: "Item No. 570-1-2 Performance Turf, Sod (Zoysia) (**Bahia**) Square Yard."
- **C.** Regarding Drawings, Sheet 2, Bid Items and Summary of Quantities (and all applicable referenced locations), **REVISE** to read as follows: Zoysia <u>Bahia</u>
