## ADDENDUM #1

The following are questions, with respective answers, for the above Invitation for Bids:

1. QUESTION – Page 23, Lot 1, Section 1.N: Are off-board monitor inputs / outputs allowed for easy access?

ANSWER – Input / Output shall be on-board.

2. QUESTION - Can "Vacation Switch" be handled by software through scheduling? Please describe desired functionality of this feature.

ANSWER – Yes, this is not a critical feature.

3. QUESTION – Page 23, Lot 1, Section 2.A: Is a single hex head screwdriver tool for all 6 axis points of adjustments acceptable?

ANSWER – The mount adjustments should be tool-less, using micro lateral adjustment knobs latches and tabs.

4. QUESTION – Page 23, Lot 1, Section 2.B.3: Can mounting methods be left up to bidder based on requirements of existing structures and proposed monitor mounting system to be provided?

ANSWER – No, the mount shall use a channel system as described in section 2 of Lot 1. Adjustments to the mount shall be tool-less, using micro lateral adjustment knobs latches and tabs.

5. QUESTION – Page 23, Lot 1, Section 2.C.1: Can we provide LCD modules that can be placed into service position for front access service without removal of other monitors?

ANSWER – Yes. The mount described in the section will achieve the "service position" through a tool-less cord release system via RapidDraw release cords along rails/strut channels

6. QUESTION - Will County staff remove existing video wall systems, or should bidders bid on that effort also?

ANSWER – County staff will remove existing.

IFB #Y16-637-MG Addendum No. 1 Page **1** of **2**  7. QUESTION - What type of video wall source input feeds (DVI, HDMI, DP, VGA, Analog) and counts are currently providing content to the existing video wall?

ANSWER – The existing video wall source input feeds are irrelevant as this is a complete replacement.

8. QUESTION - Can you provide additional description for the content operators wish to display on the new video wall?

ANSWER – Any available video feed from existing and future camera systems, not limited to CCTV, video detection, HTML, real time workstation screen captures, maps, network management system data, cable TV feeds and more.

9. QUESTION - What is the functionality of the 10 display PCs mentioned in Lot 2? Are they just connected to the monitors of the video wall or do they have a different function (e.g. Operators using them)?

ANSWER – The 10 PCs mentioned in Lot 2 are designated for the wall.

10. QUESTION - Are you going to accept a variation of video wall equipment running under Linux if it meets the requirements?

ANSWER – Linux is unacceptable given the limitations of the emulation necessary to run and fully support the VMS.

11. QUESTION - In Lot 3 when you describe the hardware do you mean some kind of a modem for wireless carrier?

ANSWER – The hardware described is a combination of a modem for wireless carrier and a switch for various equipment in the signal cabinet as detailed in the specifications.

All other specifications, terms and conditions remain the same
