A. CLARIFICATION

Q. Can you explain more about the Central Contractor Registration (CCR) as noted on page 1 of the Bid Docs?

- Is this something we have to get prior to bidding or award?
- Are there any costs associated for it?

A. Registration with the Federal Central Contractor Registry and submittal of a DUNNS number will not be required for this contract. This requirement will be deleted from the bid documents.

Revise the **cover sheet** of the IFB as follows (Strikethroughs are deletions/underlined text are additions):

IFB Vol. I, Part C, Instructions to Bidders

Paragraph 25. PUBLIC ENTITY CRIME STATEMENT (FS 287.133)/STATE DISCRIMINATORY/SUSPENDED VENDOR LIST:

A person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid on a Contract to provide any goods or services to a public entity, may not submit a bid on a Contract with a public entity for the construction or repair of a public building or public work, may not submit bids on leases of real property to a public entity, may not be awarded or perform work as a Contractor, supplier, subcontractor, or any entity in excess of the threshold amount provided in Florida State Statutes Section 287.017 for CATEGORY TWO for a period of 36 months from the date of being placed on the convicted vendor list.

An entity or affiliate who has been placed on the State of Florida's discriminatory/suspended vendor list may not submit a bid, proposal, or reply on this contract to provide any goods or services to the County; may not submit a bid, proposal, or reply on this contract with the County for the construction or repair of a public building or public work; may not submit bids, proposals, or replies on leases of real property for this contract to the County; may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under this contract with the County; and may not transact business with the County related to this contract for a period of 36 months following the date that entity or affiliate was placed on the discriminatory/suspended vendor list. Contractor agrees to include this provision in all subcontracts issued as a result of this Contract.

C. ACKNOWLEDGEMENT OF ADDENDA

- a. The Proposer shall acknowledge receipt of this addendum by completing the applicable section in the solicitation or by completion of the acknowledgement information on the addendum. Either form of acknowledgement must be completed and returned not later than the date and time for receipt of proposal. All other terms, conditions and specifications remain the same.
