TERM CONTRACT STORMWATER POND AND PRIMARY CANAL CLEANING  
AND RESTORATION SERVICES**

**New Bid Opening Date: May 9, 2017**

This addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. Underlining indicates additions, deletions are indicated by ~~strikethrough~~.

- A. **The bid opening date is hereby changed to May 9, 2017.**
- B. Minimum Quantity/Dollars paragraph in Page D-2 of this solicitation is changed to read: During the initial performance period of this contract, the COUNTY guarantees that the CONTRACTOR shall receive orders for a minimum of One Hundred Thousand Dollars (\$100,000.00)
- C. Part H, Paragraph 13 is changed to read as follows:

**13. PIPES AND BOX CULVERT SEDIMENT REMOVAL AND DISPOSAL**

**Pipes and Box Culverts - The work consists of sediment, debris, organic soil, exotic and other nuisance vegetation removal and disposal, as well as, pipe jetting and cleaning in designated retention ponds, open canals, box culverts and closed conduit systems. Closed conduit systems (referred to as closed or piped in this contract) include partial or complete sections of piped-in drainage canals or ponds and as box culverts within the canal, ponds or under roadways (this includes, but is not limited to, any type of pipes 15" or bigger, box culverts 32 square feet in diameter or bigger or any closed area 32 square feet in diameter or bigger regardless of length) within designated areas of retention ponds and primary canals as determined by the County's Representative.**

Hydraulic Cleaning:

1. Light (0 - 9% accumulated debris) - Per Foot
2. Medium (10 - 29% accumulated debris) - Per Foot
3. Heavy (30% and greater accumulated debris) - Per Foot

The linear foot unit price for sediment removal shall include all labor, materials, maintenance of traffic, erosion control, and any other incidentals needed to complete the work.

- D. All other terms and conditions of the IFB remain the same.
- E. The Proposer shall acknowledge receipt of this addendum by completing the applicable section in the solicitation or by completion of the acknowledgement information on the addendum. Either form of acknowledgement must be completed and returned not later than the date and time for receipt of the proposal.
