**SIDEWALK REPAIR AND REPLACEMENT**

**Bid Opening Date: November 15, 2016**

This addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. Underlining indicates additions, deletions are indicated by ~~strikethrough~~.

A. The Bid Opening Date remains as November 15, 2016.

B. The following changes are being made to the IFB:

1. In Part G of the IFB, **DESCRIPTION OF SCOPE OF WORK** make the following changes:

Work under this contract will consist of the removal and replacement of existing damaged sidewalks, driveway approaches, pedestrian ramps and curbs as directed by the Manager or designee of the Roads & Drainage Division. On occasions, the work may consist of the construction of new sidewalk areas where no previous sidewalks existed. Work to be performed under this contract shall be inclusive of the removal of roots ~~(above ground level and up to twelve inches under the sidewalk)~~ **(less than 2-inches in diameter, and up to 4-inches below ground level)**, plants, shrubs, hedges, and repairs to damaged irrigation, utilities, private property, and County right of way including curbs and asphalt.

2. In Part H of the IFB, **TECHNICAL PROVISIONS** make the following changes:

The Contractor shall furnish all labor, materials, equipment, supervision, quality control, tools, transportation, supplies, and manpower as well as pay for any applicable fees to complete the work specified in this contract. The work performed shall consist of the removal and replacement of existing sidewalks, driveway approaches, pedestrian ramps and curbs (regardless of type or thickness of concrete). On occasion, the work may consist of the construction of new sidewalk in areas where there was no previous sidewalk. Work to be performed under this contract shall be inclusive of the removal of roots ~~(above ground level and up to twelve inches under the sidewalk)~~ **(less than 2-inches in diameter, and up to 4-inches below ground level)**, plants, shrubs, hedges, and repairs to damaged irrigation, utilities, private property, and County right of way including curbs and

asphalt.

3. In Part H, 3.1.1 of the IFB, make the following changes:

**SITE PREPARATION AND CONSTRUCTION** - Clearing and grubbing shall include the removal of roots (~~above ground level and up to twelve inches under the sidewalk~~) **less than 2-inches in diameter, and up to 4-inches below ground level (enough to place the form board)**, plants, shrubs, hedges, etc. The use of fork-lifts and similar equipment to remove roots shall be restricted to the required depth **will not be allowed in order to prevent damage to underground utilities and further impact tree roots**. Proper care not to remove or disturb roots under the required depth shall be exercised at all times. **If roots required to be removed are larger than 2-inches in diameter, the County Representative must request an arborist to evaluate the tree and make a written recommendation if it is safe to cut the roots**. If the Contractor is determined not to be in compliance with this requirement, the County's Representative shall have the authority to request the Contractor to cease and desist using this methodology and the Contractor shall find an alternate method to remove roots to the specified depth. Disturbed areas shall be re-compacted per FDOT standards. Payment for site preparation and construction including root removal shall be included in the unit price for services.

- C. All other terms and conditions of the IFB remain the same.

The Proposer shall acknowledge receipt of this addendum by completing the applicable section in the solicitation or by completion of the acknowledgement information on the addendum. Either form of acknowledgement must be completed and returned not later than the date and time for receipt of the proposal.
