Qualification of Bidders, Item A, indicates listing five (5) available vehicles, three (3) with kneeling ability. Is this requirement referring

to the peak event shuttle bus or the Daily Shuttle vehicle(s)?

Answer: It is referring to the 40+ passenger bus.

5. Question: IFB indicates that Employee Shuttle will stay on Center Property. Is

this also true for the Event Shuttles.

Answer: All shuttle vehicles will travel only on OCCC property.

6. Question: Under Special Terms and Conditions, page 16, Item 6B,

Termination for Convenience, will the County consider extending section to include the bidder's ability to terminate for convenience?

Answer: No.

for Emergency/Hurricane or Disaster, will the "first priority" availability of bidder's Services and Equipment be limited to suppling those goods and services as listed in this IFB's Scope of Services or will the County require that additional services and
