If any such renewal results in changes in the terms and conditions, such changes shall be reduced to writing as an amendment to this contract and such amendment shall be executed by both parties.

## 10. CONTRACT TERM/RENEWAL

A. The contract resulting from this Invitation for Bids shall commence effective upon issuance of a term contract by the County and extend for a period of five (5) years. The contract may be renewed for two (2) additional one (1) year periods, upon mutual agreement of both parties. If any such renewal results in changes in the terms and conditions, such changes shall be reduced to writing as an amendment to this contract and such amendment shall be executed by both parties.
2. Page 21, item 12 PRICE ESCALATION/DE-ESCALATION (CPI) is changed as follows:

> The-original revenue split percentages shall be firm for the entirety of the initial (three years) contract period.

4. The following are questions, with respective answers, for the above IFB:

Question 1 - How would you expect equipment manufacture dates prior to being awarded the bid? That info would not be available to anyone prior to ordering equipment.

Answer - Bidder's existing equipment intended for these services shall be no more than five (5) years old. That is five (5) years from the date it was manufactured. All equipment ordered post contract award shall also comply. Bidder shall indicate if equipment must be ordered and provide a statement confirming understanding of this requirement.

Question 2-Are we allowed to provide newly refurbished equipment that are within five (5) years old?

Answer - We will not accept any equipment that is older than five (5) years from the date of manufacture. If the equipment is five (5) years old or less but has been refurbished then, it is acceptable.

Question 3 - Can we include exceptions with our response, if bidders will receive the purchase order for review, and whether the terms and conditions of such purchase order will be negotiable?

Answer - When completing your bid, do not attach any forms which may contain terms and conditions that conflict with those listed in the County's bid documents(s). Inclusion of additional terms and conditions such as those which may be on your company's standard forms shall result in your bid being declared non-responsive as these changes will be considered a counteroffer to the County's bid.

Question 4 - Provide the current commission percentage paid on the commissionable vending machines.

Answer - The current commission is $10 \%$.
Question 5 - Provide the total dollar amount received in commissions for the previous twelve (12) months.

Answer - Commissions for 2016 is $\$ 6,221.51$.
All other specifications, terms and conditions remain the same.
