Replace with: The Revised Schedule of Prices, REVISED Page D-3 through REVISED Page D-4 in Addendum #5.

4. The following are responses to questions received:

1. **Question:** I Was putting the bid together and realized that in Addendum #3 you did not include Line Item 18 / 522-4 / Rest Area Shelter & Trach Receptacle Pad – Concrete (6” Thick) / 20 SY

Response: Please refer to the attached “Revised Schedule of Prices” for Line Item # 18 referring to Pay Item – 522-4.

2. **Question:** Revised bid form issued with Add #3 does not contain the original bid item for 20 sy of conc for the rest shelter slab. Originally this was item 18. Please let us know if we need to make any change to our proposal which still includes item 18. I apologize for not catching this sooner.

Response: The attached “Schedule of Prices” includes a line item for 20 SY of 6” thick concrete for Rest Area Shelter & Trash Receptacle Pad.

5. All other items, conditions and specifications remain the same.

6. The Bidder shall acknowledge receipt of this addendum by completing the applicable section in the solicitation or by completion of the acknowledgement information on the addendum. Either form of acknowledgement must be completed and returned not later than the date and time for receipt of the bids.

Therefore, it shall be the contractor's responsibility to determine the quantities of materials necessary to perform the project to its completion.
