Revised Bid Opening Date: December 8, 2016

This addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to, and shall take precedence over, the original documents. Underlining indicates additions, deletions are indicated by ~~strikethrough~~.

A. The bid opening date is changed from ~~December 6, 2016 at 2:00 P.M.~~ to December 8, 2016 at 2:00 P.M.

C. Questions and Answers:

- 1. Question:** Page C-12, second sentence states, "The Base Bid and Alternates shall reflect the costs for the materials and equipment named or specified only." Please confirm that only named and specified manufactures shall be used at bid time and substitutions will be evaluated after award and any savings shall be shared in accordance with the Article 26 – Value Engineering clause as found on page F-47.

Answer: Substitution requests and shall be handled as per No. 7 of Part C – Instruction to Bidders of the Invitation for Bids. Requests for substitutions will not be considered prior to contract award in accordance with the provision. There are no shared savings on substitution requests and Article 26 – Value Engineering clause as found on page F-47 does not apply.

- 2. Question:** The bid form shown on pages D-1 and D-2 contains all three (3) project line items for a complete bid. Pages D-4 through D-7 contains the Schedule of Values for bid items 002 and 003. Please confirm that the Schedule of Values pages are to be submitted by the successful bidder after award and not along with the initial bid submission.

Answer: The revised bid form is comprised of pages D-1 through D-7 per addendum #1 dated November 23, 2016. The bid form does **not** contain a Schedule of Values. The total bid amount is comprised of three components. 001 is the base bid which is lump sum. 002 is the Utilities component and is unit priced. 003 is the Roadway component and is unit price. **The entire bid form pages D-1 through D-7 must be completed and submitted with the bid.**

Refer to sheet D-3, which was issued as part of Addendum #1, which states “Failure of the Bidder to provide pricing for all unit priced items and/or the Base Bid and ALL requested additive/deductive bid items, or alternate bids shall be cause for rejection of the bid as non-responsive”.

3. **Question:** Drawing EL041 – Note 5 – For the Cost Alternate Price, is there a height or size requirement for the curbs noted to protect poles?

Answer: There is no Cost Alternate. General Note 5 on EL041 is to be revised as follows: “POLES LOCATED IN PAVED AREAS SUBJECT TO VEHICULAR TRAFFIC/PARKING SHALL BE PROVIDED WITH 30" CONCRETE BASE EXTENDING 30" AFG, WITH 1/2" CHAMFER, AND PAINTED SAFETY YELLOW.”

4. **Question:** Please define which testing is “By Owner” and which testing is “By Contractor”.

Answer: All testing is by the Owner.

5. **Question:** We would like you to respectfully consider our A-Turf Mono product as a substitution for section 32 18 01 Artificial Grass Turf for the Jonathan Scott Pine Community Park project. The product currently specified has some differences than our monofilament product, as you can see from our comparison sheet I have provided a product that will meet the needs of this project and match the specification as close as possible. This substitution will not affect the schedule, construction details, or cost of this project.

Answer: This is a substitution request and shall be handled as per No. 7 of Part C – Instruction to Bidders of the Invitation for Bids. Requests for substitutions will not be considered prior to contract award in accordance with the provision.

6. **Question:** The project specifications in Division 05 12 00 Structural Steel, Page 5 2.3 Fabrication Item-J requests 500 lineal feet of angle 3 x 3 x ¼ , including placement of same, to be used as directed by Architect or Engineer. Is this requirement in addition to the steel detailed in the plans? If so, how is the placement to be accounted for?

Answer: That line item was carried over from a previous OCPS High School project that was used as a template for this specification and should be omitted from this project.

7. **Question:** AS101 – Keynote Legend – 11 66 00 C.2 “Goal Protection Net”- Details are not provided in specifications or on drawings regarding what the support needs to be, or the height dimensions of the nets. Please provide further information for these nets.

Answer: Goal protection net specification to be as follows:

Provide a "100'-0" long x 20'-0" high protection net with intermediate posts per manufacturer recommendations. Provide concrete base for net sleeves per manufacturer recommendations. Refer to detail attached sketch SKA01, dated 12/01/16. Detail will be incorporated into Conformed set of documents (which will be issued at a later date to the successful bidder).

Manufacturer and model numbers as follows:

- Manufacturer: Sports field Specialties (www.sportsfieldspecialties.com); Model: TFBSS420P-SG with 4" straight post and manufacturer provided ground sleeves (GS-04-30-4").
- Manufacturer: Gill Athletics (www.gillathletics.com); Model: 731190 – Straight pole bole stope, 20' high and manufacturer provided ground sleeves.
- Or other approved equal.

8. **Question:** In the front end documents it states that there is a Service-Disabled Veterans Business goal of 3% based on the project budget but no Letter of Intent form was provided. Could you forward the information to place on our letterhead?

Answer: A Letter of Intent is not required for the Service Disabled Veterans Business. The 3% you are referring to is not a goal. It is the bid preference scale for Prime registered service-disabled veteran business enterprises. Please refer to Part C of the IFB Paragraph #4.

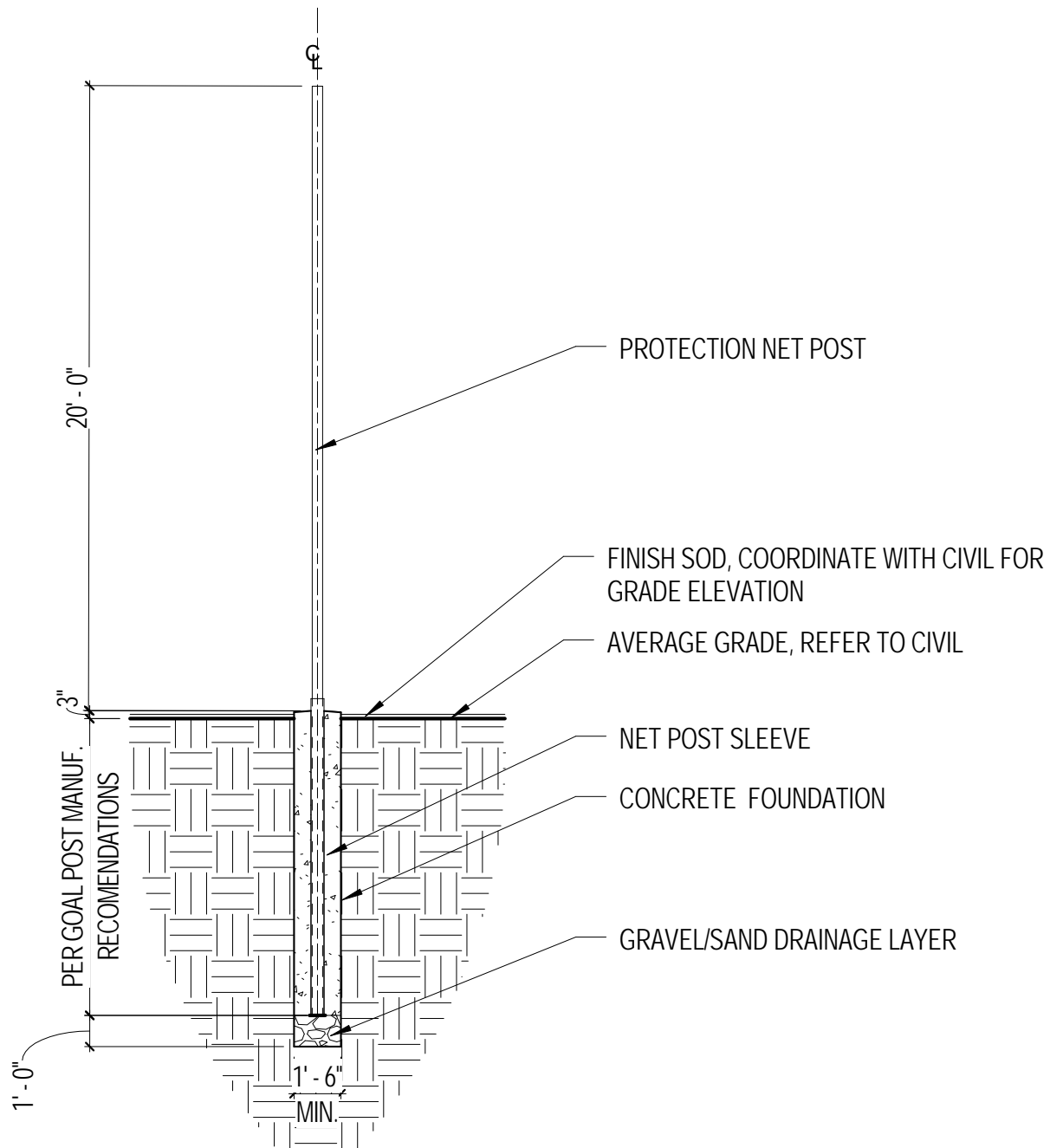
