- B. Additions, Deletions and Clarifications
  - Clarification: The Modular Building will be Owner Furnished. The Bidder will be responsible for all sitework, final electrical, water and sewer connections as well as all Contractor Furnished and/or installed items indicated on the Equipment Codes And Notes Schedule on Sheet A1.1.
  - 2. **Question:** Although we are not a construction company, I did take a moment to review the plans and I see some equipment listed as Owned by the County. For example: Tag EXAM TABLE 22"X44" Stainless Steel Owner Furnished County Installed. My question: Will these and similar items go out for bid or does the County already own them?

**Answer:** Any equipment indicated on the drawings to be Owner Furnished has already been procured. All equipment indicated to be Contractor Furnished can be competitively quoted to all bidders.

3. **Question:** I did not see anything on the plans or specs that called out the kennels/cages. Will that be a part of the bid or the FF&E package?

**Answer:** The kennels/cages will be part of the FF&E package (Owner Furnished/Owner Installed) and are NOT part of this bid.

4. Question: I have a CBC license; I have been building for 30 years and have several light commercial projects in my history like this one. Several years ago I attended a Pre-Bid Conference with Orange County and was told that only CGCs could apply. Is that the case or am I eligible to submit a proposal.

**Answer:** A CBC contractor may bid on the project providing they meet all licensing requirements in Part C, No. 16 of the IFB.
