Questions and Answers:

3. **Question:** Can you please clarify the quantity for the Bulk Liquid Chlorine? How many gallons make up the 80 each? Can this be bid per gallon?

Answer: The quantity for bulk liquid chlorine shall be bid per gallon as the total amount may vary.

4. **Question:** Are there previous bid tabs? What is each location currently paying for chemicals?

Answer: No, chemicals are currently purchased as needed by individual sites. Prices ranges from \$1.27 to \$1.95 a gallon for chlorine and \$3.13 to \$3.66 per gallon of acid.

5. **Question:** How much (quantity in gallons) of chemical (bleach & acid) is being consumed at each location?

Answer: Estimated quantities per year per site:

Dr. Phillips Park - Chlorine 1,100 gallons, Acid 450 gallons Fort Gatlin Recreation Complex - Chlorine 9,000 gallons, Acid 600 gallons Capehart Park - Chlorine 550 gallons, Acid 225 gallons Bithlo Community Park – Chlorine 350 gallons, Acid 2000 gallons Downy Park – Chlorine 1000 gallons, Acid 720 gallons Barnett Park – Chlorine 2250 gallons, Acid 450 gallons Camp Joy – Chlorine 650 gallons, Acid 120 gallons

6. **Question:** What is the County currently paying per gallon for bleach and acid?

Answer: Prices range from \$1.27 to \$1.95 a gallon for chlorine and \$3.13 to \$3.66 per gallon of acid.
