McLEOD ROAD TRANSFER STATION REPLACEMENT

This addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. Underlining indicates additions, deletions are indicated by ~~strikethrough~~.

A. Submittal date remains June 5, 2018

B. Item 6- SIMILAR PROJECT TYPE is modified as follows:

6. SIMILAR PROJECT TYPE:

The **County will contact the references of all Contractors.** The County has the right to reject any Contractors who fail to demonstrate these qualifications to the satisfaction of the County.

List similar projects successfully completed by the CONTRACTOR AS A PRIME CONTRACTOR within the last fifteen (15) years (i.e., construction declared substantially complete within fifteen (15) years of the SOQ Step 1 due date). The contact person listed as a reference shall be someone who has personal knowledge of the Contractor's performance during the referenced project. Contact persons must have been informed they are being used as a reference and that the County will be emailing them. Only projects within the continental 48 states will be considered.

"The Contractor shall submit previous successful project experience that includes all the elements below. Elements can be demonstrated by more than one (1) project and all elements are not required to be in the same project. Also, a single project inclusive of all of the elements will be acceptable to determine qualifications. All similar projects shall have one (1) or more of the following elements.

- At least one of the projects shall be a solid waste transfer station designed for at least ~~600~~ **250** tons/day.
- The remaining new construction or renovation projects can be solid waste transfer stations, material processing/recovery facilities or other industrial buildings with construction costs of at least \$15-million. Note if the project required demolition of existing facilities prior to starting construction.

EACH SIMILAR PROJECT LISTED SHALL BE LISTED WITH COMPLETE INFORMATION AS SPECIFICALLY PROVIDED ON THE REFERENCE FORM THE SPECIFIC INFORMATION ON REFERENCES MUST BE PROVIDED ON THE REFERENCE FORM. DO NOT ATTACH LISTINGS OF REFERENCE INFORMATION. FAILURE TO PROVIDE REFERENCE INFORMATION AS REQUESTED MAY RESULT IN THE REJECTION OF YOUR RESPONSE.

The determination of whether a contractor is qualified or not shall be at the sole discretion of the County. Although the County may request submission of a minimum number of similar projects for evaluation, the County's determination of a Contractor's qualifications shall not be solely based on the number of similar projects submitted.

- C. All other terms, conditions, and specifications of the RFQ remain unchanged.
- D. The Bidder shall acknowledge receipt of this addendum by completing the applicable section in the solicitation or by completion of the acknowledgement information on the addendum. Either form of acknowledgement must be completed and returned not later than the date and time for receipt of the proposal.
