**INVITATION FOR BID (IFB) Y19-104-AH; ADDENDUM NO. 1**

**STORMWATER MANAGEMENT MSBU RETENTION POND AQUATIC WEED CONTROL**

This Addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions, and/or revisions to and shall take precedence over the original documents. Additions are indicated by underlining and deletions via ~~strikethrough~~.

**A. The Bid Opening Date remains October 11, 2018 at 2:00PM.**

**B. QUESTIONS AND ANSWERS**

1. **Question:** May we also have a map of all Ponds IFB #Y19-104-AH?

**Answer:** Please refer to Y19-104-AH, Attachment 1 (MSBU Lot A) and Attachment 2 (MSBU Lot B) for maps of the ponds.

2. **Question:** Can you please send a excel spread sheet of all the to be sprayed ponds so we can copy and paste for IFB #Y19-104-AH?

**Answer:** Please refer to Item D, below, which adds Attachment 3 to the Invitation for Bids.

**C. Provision No. 16 under Special Terms and Conditions is hereby removed from the Invitation for Bids:**

**~~16. CONTRACT TERM/RENEWAL~~**

~~A. The contract resulting from this Invitation for Bids shall commence effective upon issuance of a term contract by the County and extend for a period of one (1) year. The contract may be renewed for two (2) additional one (1) year periods, upon mutual agreement of both parties. If any such renewal results in changes in the terms and conditions, such changes shall be reduced to writing as an amendment to this contract and such amendment shall be executed by both parties.~~

~~B. The initiating County department(s) shall issue delivery/purchase orders against the term contract on an "as needed" basis.~~

~~C. If the quantity of a unit priced item in this contract is an estimated quantity and the actual quantities ordered are more than 50% above the~~

~~estimated quantity, the County shall enter into negotiations with the Contractor for a lower unit price which shall be incorporated into the contract. Failure of the Contractor to agree to a reduced unit price may result in the termination of the contract and re-solicitation of the requirement.~~

~~D. Any order issued during the effective period of this contract, but not completed within that period, shall be completed by the Contractor within the time specified in the order. The contract shall govern the Contractor's and the County's rights and obligations with respect to that order to the extent as if the order were completed during the contract performance period.~~

The following provision shall prevail regarding the contract term for IFB #Y19-104-AH, as found on Page 24 of the IFB document, under Special Terms and Conditions:

## **22. CONTRACT TERM – OPTION YEARS**

The contract resulting from this solicitation shall extend for a period of one (1) year. The County may unilaterally renew the contract for the periods specified on the Bid Response Form for two (2) years.

The County may unilaterally extend the term of this contract by written notice to the Contractor at least ninety (90) days before the expiration of any contract term. The exercise of the option shall be for the period specified and for the prices listed on the Bid Response Form. All other terms and conditions of the contract shall apply to the option periods.

After all options have been exercised, and it is determined that interim performance is required to allow for the solicitation and award of a new contract, the County may unilaterally extend the contract for a maximum period of six (6) months. Pricing, delivery and all other terms and conditions of the contract shall apply during this period. **The total duration of this contract, including the exercise of all options, shall not exceed 3.5 years.**

E. Section No. 6 under the Technical Provisions is modified as follows:

**6. LOCATION OF WORK** (See Attachments A and B) Specified locations could increase due to additions of new ponds or decrease due to removal of ponds. Additional location listings will be issued as they become available. Attachments A and B plus these additional location listings (up to the maximum amount allowed for the Basic Year of the contract) constitute the total contract requirement for the Basic Year of the contract.

~~Option Year Number 1 (2nd year of the contract), Option Year Number 2 (3rd year of the contract), Option Year Number 3 (4th year of the contract) and Option Year Number 4 (5th year of the contract) cover additional acreage to be specified up to the maximum amount allowed for the specific year of the contract.~~ **Option Year Number 1 (2nd year of the contract) and Option Year Number 2 (3rd year of the contract cover additional acreage to be specified up to the maximum amount allowed for the specific year of the contract.**

The Contractor will be notified of any changes directly from the Stormwater Management Division which will provide necessary maps and details of locations to be added with the effective date of the addition and of locations being deleted and the effective date of the deletion.

**F. ACKNOWLEDGEMENT OF ADDENDA**

1. The bidder shall acknowledge receipt of this addendum by completing that applicable section in the solicitation or by completion of the acknowledgement information on the addendum. Either form of acknowledgement must be completed and returned no later than the date and time for receipt of the bid.
