HAUL RECYCLABLE MATERIALS

This Addendum is hereby incorporated into the bid documents of the project referenced above. The following items are clarifications, corrections, additions, deletions, and/or revisions to and shall take precedence over the original documents. Additions are indicated by **underlining** and deletions via strikethrough.

A. For clarification page 31, Specifications – Requirements, the following are added:

- 1. The Contractor shall cover each trailer outfitted with the roll over tarp at all times while in transport.
- 2. All trucks shall be 3000psi.to be compatible with Orange County trailers.
- 3. Personal protective equipment shall be worn at all times on Orange County property to include but not limited: clothing, helmets, goggles, or other garments or equipment designed to protect the wearer's body.

B. <u>Questions and Answers:</u>

1. **Question:** Does this current bid have an older reference point?

Answer: The previous contract, Y16-1097, is available through a public records request at: **ProcurementRecords@ocfl.net**

2. **Question:** Are the routes Monday through Friday or does it include weekend work?

Answer: The routes are Monday through Friday. Weekend work is only for overflow demands.

3. **Question:** What is the current schedule, i.e. how many hauls do they do now on average, Monday, Tuesday, Wednesday, Thursday, Friday, Saturday, Sunday?

Answer: The current schedule is Monday through Friday 7:00AM – 5:00PM. Orange County is currently pulling 6 loads a day from McCormick and 10 loads from the Landfill. 4. **Question:** Do you currently haul some of these loads with your own tractors? If so, will you continue to use your own tractors and this contract will only be to supplement your hauling needs?

Answer: Orange County is currently hauling all loads. This is an as needed contract.

5. **Question:** Is there a minimum number of hauls per day, for example will you be calling to do a single haul in a day from the material recycling facility to the landfill across the street?

Answer: No, there will be a full day's work (no single load).

6. **Question:** What is the maximum amount of tractors you will be ordering on a day?

Answer: Requests would be for 2 to 3 tractors a day.

7. **Question:** How many loads did you do last year for each of the routes? I ask because the last time this was bid, there was an estimated 24,000 loads between the material recycling facility to the landfill a 0.5 mile haul. This time, it is only 500 hauls, what has changed to account for this?

Answer: This solicitation is as needed therefore reducing the estimated loads.

8. Question: What are the hours allowable for hauling?

Answer: The hours are 7:00AM – 5:00PM, Monday through Friday

9. **Question:** Will we be able to stage any equipment overnight at any of the pickup locations?

Answer: No equipment is permitted to be staged unless it is a 6x6 truck at the landfill only.

10. **Question:** Are we responsible for maintaining the trailers? So if the trailers blow a tire, are we covering the costs to replace it?

Answer: No, the Contractor is not responsible for maintaining the trailers. If a County trailer is damaged due to negligence on the Contractor's part then the Contractor is responsible for repair/replacement.

11. **Question:** We don't currently have workers comp, and obtaining with would increase our costs exponentially to the point where it would probably not make sense bidding given the size of the project, are you able to remove the requirement for workers comp?

Answer: We will not waive Worker's Compensation. All County insurance requirements must be met.
