The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. Underlining indicates additions, deletions are indicated by ~~strikethrough~~.

A. Bid Opening Date is changed from ~~September 19, 2019~~ to September 24, 2019 at 2:00 P.M.

B. CLARIFICATIONS

1. Q: Drawing FP101 shows to remove and discard existing fire sprinkler system in New Maintenance Building. Is new fire sprinkler going to be built by others? Please confirm.

A: The existing fire sprinkler system is to be removed per the Drawings. There is no new sprinkler system proposed for the New Maintenance Building.

2. Q: Drawing G005 shows 8" Fire Line to be removed. Is new Fire Line to be built by others? Please confirm.

A: The existing 8-inch fire line to the New Maintenance Building is to be removed per the Drawings. There is no new fire line proposed.

3. Q: Drawing D101 shows existing backflow preventer to be removed. Is new backflow preventer to be installed by others? Please confirm.

A: The existing backflow preventer on the existing fire line is to be removed per the Drawings. There is no new backflow preventer proposed.

4. Q: The measurement and payment section includes 2 items. One is a lump sum amount for the work, the other is a percentage of the first amount for Permits. The bid form only has one item, lump sum amount for the work.

A: See revised Bid Form Section C.

5. Q: Will a building permit be required? If so will the fees be waived?

A: Yes, a building department permit is required. Building Department permit number is B19900002 per Section 01065. Fees shall be included in the bid as a percentage of the bid amount as outlined in Sections 01025 and 01065.

6. Q: Please provide company name and/or contact information of the vendor that installed the roofing on the new Maintenance Building.
